- 1. Cemetery Cleanup is set for Monday, October 13, 2025 at 9:00 am.
- 2. Cemetery Fee Schedule was discussed with comparisons of neighboring cemeteries and their fees. Motion by Trustee Reigle Riegle, Second by Trustee Maynard to approve and adopt the revised fee schedule for the Fairfield Township Cemetery, effective January 1, 2026. Clerk Latz will update the Cemetery Ordinance where applicable. Motion carried 5-0
- 3. We received notification that our Workman's Comp Policy through Auto Owners will cease January 1, 2026. We are looking into other insurance carriers for TWP employees.

- 4. Revenue Sharing is being decreased for 2026 with the State of Michigan's adopted 2026 Budget. Early projections are approximately a \$3,260 decrease to Fairfield TWP for 2026 but the final numbers have not been determined.
- 5. Annual Local Unit Fiscal Report has been received from the State and is on file.
- Trustee Riegel Riegle made a motion, Second by Trustee Maynard to do an Interfund Budget Amendment for moving \$10,351.69 from General Savings to Road Checking for the paving and sealing of Meridian Road. Motion passed 5-0
- 7. Options for housing the EAFD were discussed.
- 8. Motion by Supervisor Zemla, Support by Trustee Riegel Riegle for the support and renewal of the Shiawassee Economic Development Partnership investment of \$500. Motion passed 5-0
- Michigan Township Association will be presenting a class on "Planning for a Millage" for \$25. Motion by Trustee Riegel Riegle, Second by Trustee Maynard for Supervisor Zemla and Clerk Latz to the class in preparation for a possible future millage request. Motion passed 5-0
- 10. Road Commission projected 2026 Projects is to chipseal 3 miles of Carland Road.
